**Poster Presentation Guidelines.** The poster should be A1 size (84.0×59.4 cm) and include the following information: full name(s) of the author(s), name of the institution, author(s)' email address, title of the presentation. This information should be placed at the top of the poster in accordance with the formatting used in the conference abstracts.

#### REQUIREMENTS FOR CONFERENCE PAPER SUBMISSION

Conference materials must be prepared using *Microsoft Word*. The file name must correspond to the surname of the first author, written in Latin script (e.g., Korzhyk.doc).

Page format: A4

Length: up to **two** pages Font: **Times New Roman** 

Font size: 12 pt, single line spacing (1.0)

Margins: 2 cm on all sides, paragraph indentation: 1 cm

Symbols: use **Symbol** font for special characters

Text alignment: **justified** 

The materials should be formatted as follows:

- 1. First name and surname of the author (in bold, right-aligned), provided in both Ukrainian and English.
- 2. Institutional affiliation(s) of the author(s), including institution name and email address(es) (also right-aligned).
- 3. After one blank line, the title of the abstract in Ukrainian (in bold uppercase letters, font size 14 pt, centered).
- 4. After one blank line, the title of the abstract in English (in bold uppercase letters, font size 14 pt, centered).
- 5. After another blank line, the main text of the abstract, justified. Latin species names should be italicized.
- 6. In-text references must be given in parentheses, indicating the author's surname and year of publication.
- 7. At the end of the abstract, a list of references must be provided in accordance with DSTU 8302:2015.
- 8. Materials **may** include a small table, chart, or figure (photo). **Do not use** font changes, register transformations, highlights, or additional formatting. The materials should be submitted to the Organizing Committee in .doc format via email.

Authors are fully responsible for the scientific content, novelty, accuracy, and validity of the submitted materials, as well as for proper referencing and compliance with language and formatting standards.

The Organizing Committee reserves the right to: edit or reject materials that do not meet the conference's thematic scope or formatting requirements; assign abstracts to specific sections during the preparation of the conference program.
